Im Zeitalter des Wandels von der Industrie- zur Dienstleistungsgesellschaft in Europa treten die Städte in einen Wettbewerb um Einwohner, Dienstleistungsstandorte und Investoren. Es ist daher ein von vielen Städten angestrebtes Ziel, wieder mehr Lebensqualität in den Innenstädten herzustellen. Kommentar

Cities have become the place for the most disastrous catastrophes. Destruction comes from a wide range of phenomena like earthquake, hurricanes, volcanoes, Tsunamis and others. It seems inevitable that these "natural hazards" are hitting cities even more in the future as the climate change develops its consequences. While engineering seeks for technical options for adaptation and mitigation, the main subject will be how people can develop new social practices in their daily life to survive, recapture and prevent damages of their lives. These questions are not easily to be answered and require a more profound understanding of urban life. This can only be achieved if these catastrophes are regarded in its societal context. This seminar wants to inform about a sociological perspective on natural catastrophes in cities. Its main assumption is that natural hazards only become a human disaster under certain circumstances. It will present recent approaches from sociology to understand more on the causes, effects and long lasting impacts of disasters in general. Looking back on different case studies, the seminar aims at providing a broader understanding of the context, framing, experience, reaction and recovery of disasters. Particular attention will be paid to the #post-disaster communities, the way people organize themselves during and after the disaster.

Kommentar

„In meinem Studium muss ich wissenschaftliche Texte lesen und schreiben können.“ Klingt einfach, ist es aber häufig nicht. Das wissenschaftliche Schreiben und der sichere Umgang mit dem entsprechenden Textmaterial ist ein zentraler Kompetenzbaustein im Studium. Dabei zeigt sich immer wieder eine Diskrepanz zwischen dem, was in Lehrveranstaltungen zum wissenschaftlichen Arbeiten vermittelt wird und den Herausforderungen, die sich stellen, wenn die Studierende erste eigene Texte nach den Vorgaben guter wissenschaftlicher Praxis verfassen sollen. Diesem Missverhältnis soll mit der experimentellen Struktur dieser Lehrveranstaltung entgegengewirkt werden.

Die Veranstaltung ist zweigeteilt. Im ersten Teil wird es darum gehen, zentrale Texte in der Disziplin Raumplanung & Raumforschung zu lesen und hinsichtlich ihres inhaltlichen und strukturellen Aufbaus zu analysieren.

Der zweite Teil der Veranstaltung wird überwiegend von den Studierenden gestaltet. Mit der Unterstützung der Lehrenden suchen sie sich die Themenbereiche des wissenschaftlichen Arbeitens aus, die sie vertiefen möchten. Diese reichen von der Findung einer zentralen Fragestellung über den stringenten Argumentationsaufbau bis hin zum korrekten Zitieren und Paraphrasieren. Im Rahmen eines Workshop-Wochenendes werden die Studierenden mit der Unterstützung der Lehrenden und externer ExpertInnen gegenseitig coachen. Am Ende des Seminares

sollen die erlernten Kenntnisse im Rahmen einer Hausarbeit zu einem raumplanerischen Thema praktisch umgesetzt werden.

Kommentar

Life in German cities has undergone substantial changes in the last decade. Not only the East German cities had to address new challenges after the reunification of the German nation in 1990, but also the West German cities had to reformulate their place in the complex urban networks. Cities are mirroring wider changes in German society where new social and political developments can be observed. Economic and cultural globalization has had a major impact on many aspects of urban life. This lecture will give an overview about major developments in German cities since the German reunification in 1990. It will provide both a sound source of information on the most important issues of German society and reflect important discussion of the international debate on urban studies. After delivering a historical overview of German cities, basic concepts of urban sociology will be developed by discussing subjects like gentrification, segregation, migration, life style diversity and others. The lecture provides an insight view into classical theories of urban sociology as deriving from Max Weber, Georg Simmel and the Chicago School.

COURSE DESCRIPTION

Walker and Salt described Resilience in their much quoted book "Resilience thinking - Sustaining Ecosystems and People in a Changing World" in the following manner: Resilience is "the ability of a system to absorb disturbance and still retain its basic function and structure" (Walker and Salt 2006, 1). In our course, we are going to explore the concept of resilience and how it applies to Architecture and Urban Design. The overall goal of the course "Resilience – From the Housing to the Urban Scale" (UR) is for the students to learn about urban resilience, to understand its processes and elements, and to apply this understanding. "UR" is a mainly online-based course and has four main elements: workshop, video task, paper task, and evaluation. A two-day, introductory workshop (12.-13.10.15) starts off the course. Here, students will learn about resilience theory and its practical application as well as start working on their two course assignments in an environment of collaboration and exchange. While this part of the course takes place in the classroom, all further course elements are based on the e-learning platform "moodle". For the video task, which is the second course element, each student will be required to analyze as well as reflect a best- or worst-case example provided by the lecturer and present his or her findings in a short-video presentation. All videos are uploaded onto "moodle" and shared with the other students. In the third phase of the course – the paper task – students will apply their knowledge about (urban) resilience by doing field research and by writing a short paper about it. The focus of this paper shall lie on the housing unit (its inhabitants, functionality, and construction) as the basic actor of urban resilience. The course will end with a detailed feedback by the teacher as well as an evaluation of the course by the students.

Kommentar

From socialist realism to capitalist realism. Moscow is next to Paris, London and Istanbul, the largest European city and metropole region. Although its history is intensively interconnected with the Western European history, the metropole all too often seems to elude our perception. Surprisingly enough, with a few prominent exceptions, its 20th century development and current urban planning issues are rarely inspiration for study and research. Bart Goldhoorn, the editor of the magazine Russia Project, pointed out that "nowhere the confrontation of the leading ideological systems of - the Communist revolution - but also after 1991 - the fall of Communism." And the historian Thomas Flierl noticed that "there is no other city where it becomes more visible, of how the urban planning of an Eastern European capital steadily oscillates between Western European and American urban development concepts and the search for alternative concepts." Consequently, the seminar encourages to locate and understand possible correlation of politics, architectural form and the city at large. The seminar mainly addresses the transformations of the city during the mid-1930s and after the 1990s. To create ourselves a vantage point and toolbox for discussion and writing, the studio will engage into a series of contemporary and precedent concepts in urban planning and reflect them in relation to the Russian capital. Additionally to studying the city through plans and literature, we will visit Moscow. Walking in city is an essential act in understanding the physical urban structure and spatial textures. During a one week excursion, the studio will meet and discuss with among others, urban and architectural design professionals and have a workshop at one of the Moscow architectural schools.

Vom sozialistischem Realismus zum kapitalistischem Realismus. Moskau ist neben Paris, London und Istanbul, die größte Europäische Stadt und Metropolregion. Obwohl ihre Geschichte intensiv mit der der westeuropäischen Geschichte verwoben ist, scheint sich die Metropole doch allzu oft unserer Wahrnehmung zu entziehen. Von einigen wenigen herausragenden Ausnahmen abgesehen, ist ihre städtebauliche Entwicklung im 20. Jahrhundert und aktuelle Fragen der Planung überraschenderweise nur selten Inspiration für Studium und Recherche. Bart Goldhoorn, der Herausgeber des Magazins Russia Project, weist darauf hin, dass "nirgendwo die Konfrontation der führenden ideologischen Systeme des 20. Jahrhunderts radikaler waren als in Russland. Das war so in den Jahren nach 1917 - der kommunistischen Revolution - aber auch nach 1991 - dem Fall des Kommunismus." Und der Historiker Thomas Flierl bemerkt das "an keiner anderen Stadt zugleich so deutlich zu Tage tritt, wie sich die urbane Planung einer osteuropäischen Hauptstadt zwischen der Orientierung an westeuropäischen und amerikanischen Städtebaukonzepten einerseits und der Suche nach alternativen Konzepten andererseits bewegt. Erwartungsgemäß ermuntert das Seminar dann auch mögliche Zusammenhänge von Politik, architektonischer Form und der Stadt als Ganzes aufzusuchen und zu verstehen. Das Seminar befasst sich in großen Zügen mit der Transformation der Stadt in der Mitte der 1930er Jahre und nach 1990. Um uns eine gute Basis und eine erste Gerätschaftskiste für die Diskussion und das Schreiben zu verschaffen, beschäftigt sich das Studio mit einer Reihe von zeitgemäßen und vorangegangenen Konzepten des Städtebaus, die wir dann in Bezug auf die russische Hauptstadt reflektieren. Zusätzlich zum Studium der Stadt anhand von Plänen und Literatur werden wir Moskau besuchen. Städte muss man sich erlaufen, ein unerlässlicher Akt zum Verständnis der physischen Stadtstruktur und der räumlichen Texturen. Während der einwöchigen Exkursion treffen und diskutieren wir mit unter anderem Stadtplaner und Architekten, und organisieren einen Workshop an einer der Moskauer Architekturschulen.

Reconstruction, Development and Citizens' Voices: Using quantitative analysis as supportive tool for urban planning including the application of SPSS Statistics for social research methods on urban change

This course is a preparatory module for students with a background in (landscape) architecture, design, urban planning, geography. Its main idea is to get a notion how to use social research methods in creating urban design and planning urban changes. The focus of seminars goes on the method of interview as a methodological tool to get data from recipients. Practically the course is oriented on doing a survey with the SPSS statistics, a software package for statistical analysis, as an approach of analyzing and interpreting data.

Within an interactive form of seminars the course gives students an opportunity to denote the specifics of social methods in urban research, to critically reflect contexts and applications of the method of interview in a survey, to discuss issues and cases where social research functions for efficiency and productivity of urban planning and urban design. Furthermore, the course is planned as a knowledge-sharing platform where students with different backgrounds and working/scientific experience exchange opinions, ideas and skills for doing social and urban research. Moreover, being a studying project, the course has a research case of Jena's Eichplatz which gives the students an opportunity to work with real data, to cooperate with several social institutions and to find practical ways of solving problems in the field of urban planning. The course is in English but it is of advantage, if you also bring some German knowledge to conduct the interviews.
