- 5. Four bound copies (hard or soft cover) of the dissertation, as well as a USB stick containing a digital copy of the dissertation
- 6. An abstract¹ of the dissertation signed by the applicant's supervisor. The abstract must not exceed 3 pages (4 pages, including coversheet, font size 11, font: LT Syntax Com Regular or Verdana, margins min. 2 cm, standard line spacing). This document must be submitted both digitally (as a PDF) and in paper form
- 7. Proof of doctoral fee payment (€ 100.00)

Requirements for abstract submitted with the dissertation

Abstract of the dissertation (doctoral thesis)

(see point 6 of the application)

The following guidelines are intended to help prepare the mandatory separate abstract of the dissertation. The abstract should be written so that the Graduate Admissions Committee can clearly recognise that the work meets the academic standards and can begin the doctoral dissertation submission procedure.

- A. The coversheet (first page within the bound copy of the dissertation) must include:
 - The title of the dissertation,
 - The name of the author of the dissertation (doctoral candidate)
 - The academic title sought (Dr.-Ing., Dr. rer. nat. or Dr. rer. pol.),
 - The name(s) of the supervisor(s),
 - The status of the doctoral candidate (internal, external) and
 - The date
- B. The abstract must provide clear and concise information on:
 - The problem and objective of the dissertation,
 - The academic status,
 - The methods used and
 - The main results achieved
- C. Each individual statement must be brief, precise and also understandable for non-specialists. The candidate's own academic contribution, innovative nature of the dissertation and the development of research in the relevant academic field must be evident.
- D. The individual statements in the summary must be consistently numbered, even across sections.
- E. The total summary, including coversheet, should not exceed 4 pages.
