Kommentar

This seminar aims to explore the complex and vibrant relation between the pedestrian and the city. We will look at walking as medium of urban perception as well as a mode of mobility. Starting with Charles Baudelaire, Walter Benjamin and the literary type of *flaneur* we will move to sixties' psycho geography, the concept of *dérive* and than switch over to self experience in a chosen urban environment, whether in Weimar or any other city.

In a second phase we look at the current situation of walking, check alleyways and hidden paths through the city, analyze distribution of space in streets and places and research walking as a sustainable mode of mobility in a car centered city.

Finally we search for new mobility projects that feature walking as an element of multi-modal mobility and a way to reclaim urban space.

Thanks to funds provided by *Professional.Bauhaus* we will be able to invite specialized scholars from the Universities of Munich and Grenoble for guest lectures.

Furthermore the seminar will be a test case for new forms of digital learning, introducing the new E-learning platform *moodle*.

Kommentar

The seminar will explore major aspects of urban development in Australia, also looking at the historical formation of Australian cities and the links between urban and societal development. Issues to be discussed will include: housing and housing styles; suburbanization and urban renewal; gentrification; segregation; multiculturalism, diversity and urbanity; the compact city model, urban form and sustainable development; transport and infrastructure; economic restructuring and globalisation; cities and regions; place marketing, hallmark events, cities in competition; urban resilience. The concepts employed in the course can be applied to the analysis of urban development in other Western countries, including Germany. In general, the seminar provides students of architecture and of urban studies with an understanding of urban issues as examined by urban sociologists. Being taught overseas the course will commence with an introduction to Australian society, including Aboriginal life and culture.

Cities are currently shaping the lives of more than 3.5 billion people worldwide. This makes them one of the most influential and the most complex artifacts created by mankind. The demographic and economic pressure causes that the processes of slow evolution made up of small steps which shaped the old cities for a centuries has to accelerate into one single master plan defining the lives of millions inhabitants. Big steps forward does not only increase the speed but also the impact of every decision made. These can either improve or worsen the living quality of billions. The responsibility carried by the planners makes it therefore inevitable to clearly understand the way how cities work and in particular how they influence human behavior.

However planners are more focused on single architectural elements (houses, streets, plazas) having only limited knowledge about what happens when these elements are put together. One of the major reasons for this is the enormous complexity of systems like cities which are build out of millions of different elements facilitating or interfering interactions of millions of inhabitants.

Nevertheless there are methods and tools allowing the planner to gain better understanding of this complexity and use this knowledge to materialize the design intentions into urban form.

Focus of this seminar will be on theoretical understanding and practical use of these tools and methods. During the semester we will work our way from understanding the existing city through empirical observation into theoretical models and computational analysis which can be used for the future planning.

Obwohl das Schaffen von Raum eine der wichtigsten Aufgaben von Architekten und Stadtplanern ist und die Eigenschaften gebauter Umwelt einen großen Einfluss auf das Verhalten der sich darin aufhaltenden Menschen ausüben, bleiben Aussagen von Entwerfenden hinsichtlich räumlicher Qualitäten oft wage. Dies spiegelt sich nicht zuletzt in vielen gebauten Beispielen wieder, deren Probleme auf ein mangelndes Verständnis dafür, wie Menschen Räume wahrnehmen und erleben, zurückzuführen sind.

Im Seminar wollen wir uns mit der Beschreibung von Raum auseinandersetzen und überprüfen, inwieweit objektive Aussagen zu räumlichen Qualitäten möglich sind. Hierfür werden wir uns mit computergestützten Analysewerkzeugen (Space Syntax) beschäftigen. Raum wird hierbei als die durch begrenzende Oberflächen strukturierte Umwelt begriffen, in der sich Menschen aufhalten und bewegen. Die Konfiguration dieser Oberflächen kann rechnerisch analysiert und realen Phänomenen, wie bspw. Bewegungsflüssen oder Raumeindrücken gegenübergestellt werden.

Under the concept of "Urban Resilience" we understand a broad panorama of ideas that reflect the approach that the development of a city should not take place at the environment's and future generations' expenses. Having said that, we do not, however, pledge for austerity and puritanism but for a new opulence of urban space, culture, and lifestyles. (After: Thomas Sieverts in "Resilienz" by Harald Kegler)

The seminar "Urban Resilience and Building Construction" will convey a broad knowledge about urban resilience as well as its consequences for building construction and the architectural shape. Students shall develop their ability to recognize key aspects of urban resilience in general and apply what they have learnt in an analysis of their hometowns.

The course will be held as a pilot project of the Bauhaus-University's participation in the BMBF (German Ministry for Education and Research) project "Offene Hochschulen" (Open Universities) with its program "Professional Bauhaus". This course by the Institute for European Urban Studies is targeting on online-collaboration to explore blended learning formats in the field of architecture and design education. For this purpose, two groups of students from Weimar, Germany and Addis Ababa, Ethiopia will work parallel and look at the topic from their specific local context.

Kommentar

Inspite of demographic decline in Germany in general, major German cities are growing. And, in consequence, are experiencing a shortage of housing and an increase of rents and real estate prices, especially in the more affordable segments of the housing market. Within the last year this has fostered a debate not only on housing policy as such but also on the need to build new public housing. But: there is little knowledge on how to finance, organize and actually design quality affordable housing under the conditions of urban austerity and increasing social polarization. Instead, affordable and public housing still is imaged as large housing estates with run down houses and low quality public space at the edge of the city, put together according to architects ideas and housing authorities' bilances – leading in the end to socially deprived and isolated areas. However, form and function of affordable housing in Germany have changed dramatically since the "end of public housing" was proclaimed in the 1980ies and subsidized affordable housing became a niche of housing production.

Within the lecture series we will take a close look on institutional, urban and architectural forms as well as the societal function of public housing nowadays. We will discuss not only the history, but especially current models of public housing in Germany, Europe and beyond. Doing so, the lecture will take on an interdisciplinary perspective: We will discuss the development of public housing in the context of welfare state as well as urban transformation processes. But also we will look at institutional questions (policy instruments, operating, financing) as well as the urban and architectural design of public housing.

This seminars aims at discovering the local logic as well as the more general aspects behind these conflicts. The seminar will consist out of three parts – an introduction to the theory of conflict, a review of selected events and the analysis of the spaces where these conflicts manifested themselves. Is there a connection between space and conflict? How do conflicts transform spaces – physically as well as socially and symbolically?

Kommentar

Cities across the globe are facing the reality of climate variability. Climatic threats such as floods, storm surges, sea level rise are predicted to have negative effects on human, economic and environmental assets. Urban areas in low- and middle-income nations are particularly at risk. They account for already more than a third of the world's total population and they are likely to house most of the world's demographic and economic growth in the next 10–20 years. Such growth does not come without consequences in a global and climatic changing environment

Extreme events have disastrous consequences across the globe resulting in financial, social and environmental losses. Since Hurricane Katrina's destruction in 2005, the world has seen heavy flooding across Africa in 2009, 2011 and 2013; the effect of a Tsunami in Japan in 2011; the damages caused by Hurricane Sandy in North America and

the Caribbean islands in 2012 as well as the most recent destructions from Super Typhoon Haiyan in the Philippines. The world has experienced tremendous challenges to anticipate, cope with and recover from these extreme events.

Global environment changes (including extreme weather events, unregulated processes of urbanization as well as economic and conflict related migration) will make the whole issue of housing even more relevant in the future. The question of housing in connection with growing demands and pre-conditions for adaptation to climate change needs to be considered in the framing of sustainable housing development.

This course highlights the specific impacts and innovative responses towards climate adaptation in housing particularly at the intersections of formal and informal systems. It discusses how extreme events have transformed the localization, construction and maintenance of housing and particularly what are the drivers and impact of climate-related events and how have they shaped the vulnerability and responses from planning, design and policies in the housing sector. The course will couple social and ecological research perspectives as well as methodological approaches. It will provide a characterization of the territorial systems, an analysis of trade-offs and will explore ideas on ongoing processes of internal displacement and relocation, environmental and social vulnerability, resilience and planning recovery.

Not only the East German cities had to address new challenges after the reunification of the German nation in 1990, but also the West German cities had to reformulate their place in the complex urban networks. Cities are mirroring wider changes in German society where new social and political developments can be observed. Economic and cultural globalization has had a major impact on many aspects of urban life. This lecture will give an overview about major developments in German cities since the German reunification in 1990. It will provide both a sound source of information on the most important issues of German society and reflect important discussion of the international debate on urban studies. After delivering a historical overview of German cities, basic concepts of urban sociology will developed by discussing subjects like gentrification, segregation, migration, life style diversity and others. Kommentar

Inspite of demographic decline in Germany in general, major German cities are growing. And, in consequence, are experiencing a shortage of housing and an increase of rents and real estate prices, especially in the more affordable segments of the housing market. Within the last year this has fostered a debate not only on housing policy as such but also on the need to build new public housing. But: there is little knowledge on how to finance, organize and actually design quality affordable housing under the conditions of urban austerity and increasing social polarization. Instead, affordable and public housing still is imaged as large housing estates with run down houses and low quality

public space at the edge of the city, put together according to architects ideas and housing authorities' bilances – leading in the end to socially deprived and isolated areas. However, form and function of affordable housing in Germany have changed dramatically since the "end of public housing" was proclaimed in the 1980ies and subsidized affordable housing became a niche of housing production.

Starting point of the seminar is the question whether and in what way a specific new model of social housing has evolved in different national contexts through the neoliberal transformation of welfare states (at the national level) and urban policies (at the local level). To answer this question, the seminar will take in international perspectives. Building on the input of the lecture series "Housing for Everyone" and against the background of the German and European case studies presented in the lecture series, the seminar will discuss international examples of public housing. Students will prepare research reports on international case studies using their own national background as a starting point for discussion. The synthesis of the seminar's discussion on international case studies of public housing will be presented in the final session of the lecture series.

Part of the seminar is an excursion to historic and present developments of public housing in Berlin that can be seen as a laboratory of public and affordable housing (October 30th to November 1st).
