## Call for Applications: Women's Promotion Fund 2025 | 2

## 1. Objective

With the fund, the Equal Opportunity Office supports projects that contribute to the qualification and career development of women and/or TIN\* persons<sup>1</sup> at Bauhaus-Universität Weimar. In addition, the Equal Opportunity Office uses the Women's Promotion Fund to support projects that focus on gender issues in research and teaching or aim to increase the proportion of female and/or TIN\* students in STEM subjects.

The Equal Opportunity Officer and the Equal Opportunity Advisory Board of the Bauhaus-Universität Weimar together with the Presidium have defined the funding criteria. The promotion of women through the fund is anchored in the Equal Opportunity Plan of Bauhaus-Universität Weimar, as is the diversity-sensitive orientation of equal opportunity work, which aims to ensure equal opportunities for persons of all genders and to reduce discrimination based on gender.

#### 2. Target group and lines of funding

The target groups of the fund are female and/or TIN\* students, academic staff, doctoral students, postdocs and professors. The amount of funding is contingent on the available funds allocated to each application round.

Each applicant can submit one application per funding line only. Funding lines:

#### I. Funding for female and/or TIN\* students

- Funding of students' projects that serve their studies and qualification
- Allowance to offset material expenses for research projects and project work
- max. funding amount: 500,-€

#### II. Support for female and/or TIN\* scientific and artistic employees and doctoral students

- Support for the qualification of female and/or TIN\* scientific and artistic employees, doctoral candidates and postdocs
- Allowance to offset material expenses for research projects and project work
- Financial support for publications
- max. funding amount: 1.000,- €

## III. Funding of projects

- eligible to apply: scientific and artistic staff, postdocs and professors\* (female and/or TIN\*)
- max. funding amount 2.000,- €

# (a) to increase the proportion of women and/or TIN\* persons in STEM courses of study Projects and schemes to increase the proportion of female and/or TIN\* students in scientific and technical courses of study

## (b) on the topic of gender in teaching and research

Projects and plans for gender research and the implementation of gender aspects in studies, teaching and research (long-term projects and sustainable anchoring of projects). Interdisciplinary projects are explicitly encouraged.

#### Excluded from funding are:

- daily allowances and catering expenses
- costs for purchasing or leasing equipment, which can be borrowed at no charge in the faculties<sup>2</sup>
- costs for purchasing licenses or software, which can be used at no charge in the university <sup>3</sup>
- insurances (engineering insurances, accident insurances etc.)
- costs for literature, which is available at the university or can be suggested to be purchased by the library<sup>4</sup>

#### We support sustainable travel.

Flight costs for trips with less than 1.000 km distance can only be funded if one-way travel time is min. 12 hours (acc. the Thuringian Travel Expenses Act as well as resolution of universities directorate per 17.02.2021). In justified exceptional cases, the Commission will decide on the funding of air travel costs.

#### 3. Application procedure

Please fill in the online-application form (<u>Bauhaus-Universität Weimar</u>: <u>Application for project funding through the Women's Promotion Fund</u>) and the application form (PDF) and upload the necessary additional documents combined in <u>one single</u> PDF document:

## IV. Confirmation of status

- Students: confirmation of student status
- Doctoral students: admission letter by the faculty's graduation board of the Bauhaus-Universität Weimar
- V. Statement by the supervisor or supervising professor
  - brief, informal statement by the supervisor or supervising professor or academic employee of the Bauhaus-Universität Weimar (with a confirmation of the responsible holder of the professional chair), including a comment on the feasibility of the project, where applicable explanation why the professorship cannot finance the project

#### 4. Application deadline

Applications must be submitted via the online-form by **November 15 2025** at the latest.

#### 5. Award procedure

All applications submitted by the deadline are reviewed by the Equal Opportunity Officer and Equal Opportunity Advisory Board. Together they select projects and recommend funding, for which approval from the Presidium has to be required. All applicants are notified of the decision in writing.

The quality of the project as well as the relevance for the academic and artistic career of the applicants are important criteria. Furthermore, selection criteria include the project's timelines, socio-political relevance, contributions to university life or policy, potential impact on other students' work or on life in the greater Weimar area. In addition to performance-based criteria, social factors (e.g., care obligations) will be considered as well.

#### Moreover, the following formal selection-criteria apply:

- Late applications will not be considered.
- Incomplete applications will not be considered; however, applicants may submit missing parts *before* the deadline expires.
- Already completed projects/project parts do not qualify for funding, i.e., applicants can only be reimbursed for project costs that incur *after* the application deadline.
- To be able to support as many women and/or TIN\* persons as possible, the jury will prioritize applications from women who have not yet received funding from the

Women's promotion fund the past. Nevertheless, women and/or TIN\* persons who have already received funding from the Women's promotion fund may apply.

#### 6. Disclosure and reporting

The funded projects are announced publicly to the university community.

A final report must be submitted (presentation and significance of the project, assessment of implementation, opportunity for feedback).

The report must be submitted promptly after completion of the project, at the latest by November 14 2026. Please use our online form for this purpose. You will receive the link to the form in your confirmation letter.

#### 7. Project realization

When carrying out their funded projects, the applicants are obliged to expend funding in accordance with their submitted finance plan and timetable. The funding of the projects is carried out on an expenditure basis. The management policies of the university apply. The settlement takes place promptly after the end of the project, however, no later than November 14, 2026.

#### 8. Notice
