

## In-Person Exam Regulations During COVID-19 [As of: 09.02.2022]

1. The current study and examination regulations are in effect, as are the General Regulations for Managing the Effects of the Coronavirus Pandemic on Studying and Academic Affairs and its 3rd amendment ([Link](#)).
2. Please observe the following:
  - The general recommendations provided by the Robert Koch Institute ([Link](#)), as well as
  - the Bauhaus-Universität Weimar Basic Hygiene Plan ([Link](#)).
3. A valid 3G status is required to enter university buildings. Be sure to have your proof of 3G status (vaccinated, recovered, or tested) with you. This will be checked by the compliance teams. Be sure to check the latest regulations on vaccinated and recovered status ([Link](#)). Individuals who do not provide valid proof will not be permitted to enter the examination room. For the 2021/2022 winter semester examination period, the House Rules in accordance with § 30, Para. 1, Sentence 1 of the Thuringian Higher Education Act (ThürHG) are transferred by the President to the compliance check teams and proctors in order to implement § 25 of the Thuringian SARS-CoV-2 Infektionsschutz-Maßnahmenverordnung (infection prevention ordinance).
4. All participants must wear a mask (medical mask or FFP2 mask is recommended) when entering and exiting exam buildings, when moving between rooms and when seated. If the exam is being held in the Sporthalle, shoe coverings will be distributed on site.
5. Seats are to be occupied according to the hygiene measures; be sure to follow any instructions given by the examination supervisor. (Keep at least one empty space)
6. It will be possible for you to disinfect your hands before entering exam rooms.
7. Individuals who are sick or experiencing cold symptoms should not attend in-person exams. By doing so, you are protecting yourself and others from potential infection. Individuals experiencing COVID-19 symptoms may not participate in exams. If similar symptoms are due to another illness, medical proof must be provided.
8. Individuals who are under mandatory quarantine at the time of the exam may not participate in the exam. The same applies to individuals who have had contact with anyone infected with the SARS-CoV-2 virus. Please be aware of the regulations outlined by the »Thüringer Ministeriums für Arbeit, Soziales, Gesundheit, Frauen und Familie« (Thuringian Ministry of labour, social affairs, health, women and family affairs) ([Link](#)).
9. Disinfectant wipes will be available on site or at your seat. Before leaving, students must wipe down their seats and tables (including backrest) themselves and dispose of the wipes as they leave the exam room.
10. Avoid gathering outside the examination premises before and after the exam.
