### **Doctoral studies at the Bauhaus-Universität Weimar**

At the BUW, you can earn a doctoral degree either in an established doctoral programme or in a course of study tailored specifically to you. Information and support is available through the **Bauhaus Research School**, a central academic institution of the Bauhaus-Universität Weimar and umbrella organisation for young academics.

### **Obligation to publish**

The doctoral regulations of the various faculties and the examination regulations for the Art and Design/Fine Art/Media Art doctoral programme culminating in the degree of doctor of philosophy (Ph.D.) require candidates to submit depository copies of their dissertations to the library. The submission options are as follows:

- 1 electronic document and 6 bound print copies
- 3 publisher copies, for dissertations released by a publishing house or journal
- 20 bound print copies

Ph.D. candidates are required to document at least the academic part of their dissertations completely and provide an abstract of the artistic/design part of their dissertations. Delivery of the required copies to the University Library is a prerequisite to conferring the doctoral degree. The library provides copies of the dissertation to other universities and libraries as part of the literature exchange between libraries.

### **Notes on format**

The required copies of the dissertation must conform either to the version submitted and defended or to an amended version incorporating the recommendations of the examination committee. In addition to the text, the dissertation must contain the following elements:

- Title page in the format specified in the doctoral regulations
- Date on which the dissertation was defended
- Evaluator's comments
- Declaration of Honour
- Curriculum vitae

In electronic copies, the curriculum vitae may be substituted by blank pages. Acceptable paper formats are DIN A4 and DIN A5; the pages may be printed single- or double-sided. The binding should be paperback, at a minimum. Spiral bindings and other binding methods using metal or plastic parts are not acceptable.

### **Submission in digital form**

Dissertations in electronic form must be submitted through the **OPUS** (<http://e-pub.uni-weimar.de/opus4/home>) publication portal. If you are considering publishing your dissertation soon through a publishing house find out from the publisher if it is possible to pre-publish or simultaneously publish your work online. Parallel publication on the OPUS server of dissertations published in series by the Bauhaus-Universität Weimar's publisher,

VDG Verlag Kromsdorf, in the form in which they were submitted for the doctoral degree it is both possible and provided for in the contract between the publisher and the university. More information about the OPUS publication portal is available in brochure no. 18. Candidates who initially publish their dissertations on OPUS are free to publish additionally in printed form with a publisher.

### **Submission in print form**

If you opt to publish through a publishing house, please note that your work must be identified as a dissertation of the Bauhaus-Universität Weimar. The obligation to publish is not fulfilled until the library receives its three publisher copies. Submission of a contract with a publishing house is not suitable as proof of publication.

Since the passage of the amended German intellectual property law (UrhG) in 2014, owners of academic works which fulfil certain conditions are afforded the right of secondary publication of these works in online repositories, even though this right may not have been afforded in the publication contract concluded with the publisher upon initial publication. OPUS enables this type of secondary publication.

You also have the option of providing the library with 20 copied and bound copies of your dissertation. The doctoral candidate assumes the cost of the copies. The Bauhaus Research School provides support in the form of printing-cost grants to help cover the cost of publication
